- b) Field Testing Resolution Mr. Rozakis reported that the Board of Regents is considering making field testing mandatory. As of now, field testing is voluntary. Many Suffolk County districts have taken a stand in opposition of further testing students to assist test making companies in creating their product. Mr. Rozakis provided the Board of Education with a sample resolution should the Board decide that it also opposes mandatory field testing. The Board will place this resolution on the February meeting agenda for consideration.
- c) YMCA Mr. D'Amico discussed a new option for the after school childcare needs of the community. The YMCA after school program is an option that places emphasis on communication and activities for families, and offers enrichment to the children enrolled. Pricing will be officially presented at a future meeting.
