CALL TO ORDER

The meeting was called to order at 6:00 p.m. by Mrs. Dell'Erba, President. A motion to enter executive session for the purpose of discussing the employment history of particular individuals and advice from counsel was made by D. Noesi, seconded by D. Sonkin and approved. (5-0) Public session resumed at 7:30 p.m. at which time Mrs. Dell'Erba, President, led the assemblage in the Pledge of Allegiance.

APPROVAL OF MINUTES

The Minutes of the Regular Business Meeting of April 11, 2022, Board of Education Work/Study meeting of April 25, 2022, and Board of Education Special Meeting of April 26, 2022 were approved on motion by D. Noesi and seconded by T. Patiri. (5-0)

APPROVAL OF TREASURER'S AND BUSINESS OFFICE FINANCIAL REPORTS The Treasurer's Report and Business Office Financial Reports and Extra Curricular Fund Report for March 2022 were approved on motion by L. Jurs and seconded by D. Sonkin (5-0)

SUPERINTENDENT'S REPORT

Student Delegates Report – Students Kate O'Brien and Alyssa Watral reminded all to save the date for the spring carnival being held on Saturday, May 21 at the Grade School. They reported on the Fine Arts department announcing that Shelby Kowalewsky and Vanessa Espinoza, as well as 28 art honor society students, had their artwork chosen to be displayed at the Heckscher Art Museum this month and that several other art students had their artwork displayed at the Babylon Village Then and Now Art Show and the LI Media Art Show. They reported on the world languages department and the upcoming Annual Student/Teacher talent show. The Natural Helpers had its very first student training session and the English Department reports that Sofia Consentino, seventh grader, has been selected as Honorable Mention for her poem "Sun After a Storm" in the annual Walt Whitman Student Poetry Contest. They also reported on the recent, and successful, "Poem in Your Pocket Day," which was held on April 28, 2022.

- Mrs. Rozzi announced that this past school year saw the initial launch of the Universal Pre-Kindergarten (UPK) for the first time ever in the Babylon School District. With the passage of the State budget this spring, Babylon is now set to receive enough federal funding that allows us to double the size of the current UPK program. The UPK Lottery takes place on May 25, 2022 at 5:00 p.m. at the Babylon Elementary School. Interested families who wish to register for the UPK lottery can still register. This year, we will be offering three UPK locations: South Shore Children's Center will run one program housed inside Babylon Elementary School, as well as one program housed in the Early Childhood Center at their East Islip location, which provides wraparound AM and PM childcare services for working families; Cross of Christ Church will house the third option located at their Deer Park Avenue location right in Babylon Village. Again, to be considered for the UPK lottery, parents and guardians must sign their children up on or before the deadline of May 18, 2022. Registration can be obtained from the district's website.
- Mrs. Rozzi also reported on the updated document that details changes to existing masking
 procedures. Specifically, if a student is considered to have been exposed to another person infected
 with COVID, he/she or their parents have the option to mask or not regardless of vaccination
 status. Although masking is still recommended by health care providers when exposed to COVID,



- it is not mandated that a student mask if simply exposed. Additional information has been sent home to families.
- The Babylon Teachers' Association Scholarship night is one of the greatest events of the year. The thought, planning and implementation of the evening is a huge undertaking, honoring those students worthy of recognition for their academic excellence as well as growth. We thank the BTA for planning this annual event, which will take place under the illustrious lights of Walter William Field this season.
- The upcoming School Budget Vote and Trustee Election has once again proposed an educationally strong and fiscally sound budget that delivers excellent value for all Babylon students, families and district taxpayers, while supporting the programs our practitioners have developed over the years. The 2022/2023 proposed budget presents a 0% tax levy increase, the lowest increase since the inception of the Tax Levy Cap legislation. It is a proposed budget that champions the quality education that our Babylon community deserves - strong academic outcomes that drive the college and career success of all students, vibrant music and art programs, as well as all interscholastic sports and extracurricular clubs that match personal student interests. It is one that promotes small class sizes, expands the current UPK program and enhances academic interventions as well as social/emotional supports for students through additional personnel: two new reading specialists, one new math specialist and an additional guidance counselor. It is also a budget that introduces our community to a new transportation provider, Suffolk Transportation Services, which will offer excellent and well-rounded service to all riders. The district's financial rating remains as strong as ever, and our schools remain exemplary. Moreover, we value the strong partnership our schools have enjoyed with the Babylon community over the years. With that, we encourage every employee to vote in his or her local school budget vote and trustee election, universally scheduled for Tuesday, May 17, 2022.
- Mrs. Rozzi stated that schools must be safe, nurturing spaces where students, as well as employees, are empowered and can feel confidentially heard. The district has spent the last number of months reviewing and revising district policy on fraternization and reporting procedures. We have developed consistent building level protocols expected for detailed follow-through with accountability measures set in place; we have launched the Let's Talk! Platform that ensures new procedures are now assigned and follow-up is tracked. We also brought in additional education programming for all staff on the topic of Sexual Harassment this year. Finally, in partnership with the Suffolk County Executive's Office and the Crime Victim's Center, Babylon has the opportunity to pilot a new Student Ambassador program comprised of a group of current students who bring positive advocacy to very much a national issue. Additionally, any person within our system who may need the confidential support of an advocate, even if it is not school related, can have one through the Center. In addition to this, our partnership will allow for an array of training to school district employees, students and officials focused on disclosures as well as prevention programs, now also including cyber safety. It is our hope that we can lead the way for other districts throughout the county, region and state. On behalf of Babylon Schools, we look forward to closing out the year together as we celebrate the wonderful accomplishments of all students.

BUDGET HEARING PRESENTATION

Mrs. Rozzi turned the floor over to Mrs. Lunetta, Assistant Superintendent for Business, to present the annual budget hearing presentation for the 2022/2023 school year. Mrs. Dell'Erba thanked Mrs. Lunetta for this evening's review of the budget and for all of her hard work on the proposed budget.

Questions and comments were received from G. Hortsmann, D. Skarulis and A. Campagna regarding reporting procedures for child abuse/sexual misconduct in a school setting and the new program, Let's Talk!, the district's counsel services, Suffolk Transportation Services software for bus routes and fuel charges, elementary librarian, high school assistant principal position and extended school year.

Mrs. Rozzi thanked the three retirees listed on the board agenda this evening and wished them all well. She also recognized both Dr. Campbell and Mrs. Shelbi Feldman who are also listed on the agenda this evening resigning from their positions this year.

WHEREAS, the Babylon Union Free School District, an educational/municipal corporation is desirous of selectively participating with other educational and/or municipal corporations in the State of New York in joint bidding in the areas mentioned above pursuant to General Municipal Law §119-0 and Education Law Section 1950; and

WHEREAS, the district is a municipality within the meaning of General Municipal Law §119-n and is eligible to participate in the Board of Cooperative Educational Services, Second Supervisory District of Suffolk County (hereinafter western Suffolk BOCES) Joint Municipal Cooperative Bidding Initiative in the areas mentioned above; and

WHEREAS, with respect to all activities conducted by the Western Suffolk BOCES, the District wishes to delegate to Western Suffolk BOCES the responsibility for drafting of specifications, advertising for bids/proposals, accepting and opening bids/proposals, tabulating bids/proposals, awarding the bids/proposals, extending awards of bids/proposals, and reporting the results to the district.

BE IT RESOLVED, that the district hereby appoints Western Suffolk BOCES to represent it and to act as the lead agent in all matters related to the services as described above; and BE IT FURTHER RESOLVED that the district hereby authorizes Western Suffolk BOCES to place all legal advertisements for any required cooperative bidding in Newsday, which is designated as the official newspaper for Western Suffolk BOCES; and BE IT FURTHER RESOLVED that this Agreement with the district shall be for a term of one (1) year as authorized by General Municipal Law §119-0.2.j.

Curriculum and Development, Travel and Conferences, etc; Coaching by staff on reassignment: there are no teachers who are on reassignment coaching.
