CALL TO ORDER

EXECUTIVE SESSION

The meeting was called to order at 6:33 p.m. by Mr. Brunjes, President. At this time a motion to move into Executive Session for the purpose of discussing negotiations with the administrative group and advice from counsel regarding an alleged wrongful termination of an employee, proposed amendment to employment contract of a particular person and an employee disciplinary matter was made by Mrs. McKeown, seconded by Mr. Bencivenga and approved. (5-0). The Board resumed public session at 7:34 p.m. at which time Mr. Brunjes led the assemblage in the Pledge of Allegiance.

SUPERINTENDENT'S REPORT

Student delegate, Adam Marrone, reported that Students Against Destructive Decisions held a week of awareness from April 4-8. The Drama Club produced The Laramie Project which was held this past weekend told the story of Matthew Shepard, a college student, who was the subject of a hate crime in 1998. He also reported on other activities in the Babylon Junior-Senior High School. Dr. Peter Daly presented the proposed 2011-2012 school budget and addressed questions from visitors.

- 20. APPROVAL OF A RESOLUTION AUTHORIZING THE EXECUTION OF AN INTER-MUNICIPAL AGREEMENT WITH SUFFOLK COUNTY FOR PROCUREMENT OF NATURAL GAS: WHEREAS, sub-division (c) of section (1) of Article IX of the New York State Constitution provides that "Local governments shall have power to agree, as authorized by act of the legislature, with the federal government, a state or one or more other governments within or without the state, to provide cooperatively, jointly or by contract any facility, service, activity or undertaking which each participating local government has the power to provide separately...;"and WHEREAS, subdivision (1) of section 119-o of Article 5-G of the general Municipal Law provides, in part, that "In addition to any other general or special powers vested in municipal corporations and districts for the performance of their respective functions, powers or duties on an individual, cooperative, joint or contract basis, municipal corporations and districts shall have power to enter into, amend, cancel and terminate agreements for the performance among themselves or one for the other of their respective functions, powers and duties on a cooperative or contract basis or for the provision of a joint service...;"and WHEREAS, paragraph (d) of sub-division (2) of section 119-o of Article 5-G of the General Municipal Law authorizes agreements relating to "purchasing and making of contracts subject to general laws applicable to municipal corporations and school districts;" and WHEREAS, sub-division (a) of section 119-n of Article 5-G provides that "The term 'municipal corporation' means a county outside the city of New York, a city, a town, a village, a board of cooperative educational services, fire district or a school district"; and WHEREAS, Babylon Union Free School District is an educational/municipal corporation and WHEREAS, Babylon Union Free School District has determined that, in the interest of realizing cost savings, it is to its advantage to participate, through Suffolk County's Department of Public Works, in Suffolk County's bidding and award procedures for the procurement of natural gas, by including the demand for natural gas of Babylon Union Free School District in the County's request for bidders; and WHEREAS, it is in the mutual interest of Suffolk County to include Babylon Union Free School District demand for natural gas in its request for bidders for natural gas for County facilities, in order to maximize purchasing value and obtain a more favorable price, which will amount to a cost savings for Suffolk County; NOW, THEREFORE, be it, RESOLVED, that Peter R. Daly, Deputy Superintendent is hereby authorized, empowered, and directed to enter into an inter-municipal agreement with Suffolk County, in a form acceptable to the Board attorney, pursuant to §119-o of the General Municipal Law, to promote efficient and economical purchasing opportunities for natural gas; and be it further RESOLVED, that such agreement shall provide that Babylon Union Free School District and any of its affiliates, successors, and assigns shall be solely responsible for payments due the successful contractor or vendor for their individual purchases."

As there was no other business, the Board moved on to the next item.
